A Clearance is required for a player to switch between Clubs. The Clearance must be signed by the Existing Club and Association, along with the player seeking the Clearance. A player submitting a Clearance may not play at the Future Club until the Clearance is approved and processed. Playing at the Future Club before such time will result in the player being deemed Ineligible, and the team Forfeiting the game.

Clearance Form Instructions

1. Applicant completes Section 1 and 2 then takes the Clearance to their Existing Club (preferably by email).
 - a. **Or** if you answered CAT-1 or CAT-2 to the Restricted Player Question, submit the form to the future club and they will submit the form to your existing club, should they accept your Clearance. Clubs are limited to 2 Restricted Player Clearances (only 1 Cat-1) per age group per season.
2. Existing Club completes Section 3 then forwards to Seahawks Basketball Competitions Manager
3. Seahawks Basketball Competition Manager forwards completed Clearance to Future Club
